4. ALL ELECTRICAL CONNECTION ARE TO BE INSTALLED BY A LICENSED PROFESSIONAL ELECTRICIAN.
5. LOCKOUT / TAGOUT ANY DAMAGED EQUIPMENT BEFORE REPAIRING.

MATERIALS: TANK TO BE ONE PIECE MOLDED OF HIGH DENSITY POLYETHYLENE (COLOR: NATURAL), STAND TO BE POWDER COATED MILD STEEL (COLOR: BLACK), MIXER WETTED PARTS TO BE 316L S.S., DRAIN FITTING TO BE PP/EPDM, DESIGNED FOR CONTENTS TO 1.7 S.G. @ 73° F @ 2000 CPS MAX. PER ASTM D1998-06 FOR TYPE II TANKS USING A 600 PSI HOOP STRESS. TANKS ARE MOLDED FROM RESIN THAT IS FDA COMPLIANT AND CONFORMS TO NSF/ANSI STANDARD 61.

8. OPERATING TEMP: 73° F DESIGN
9. ALL HDPE WELDS TO BE HAND WELDED W/ NITROGEN GAS
10. ORIENT ALL FITTINGS FROM PLAN VIEW
11. TANK AND STAND REQUIRE 100% BOTTOM SUPPORT
12. ALL PIPING & VALVES MUST HAVE ITS OWN SUPPORT AND ALLOW FOR TANK EXPANSION & CONTRACTION OF 1.5% DIMENSIONAL MOVEMENT. FLEX CONNECTIONS SHOULD BE DESIGNED FOR A .5° ANGULAR MOVEMENT.
13. TANK IS TO BE LOCATED INDOORS
14. TANK IS DESIGNED FOR ATMOSPHERIC PRESSURE ONLY
15. DO NOT OVER TIGHTEN PLASTIC FITTINGS AS THEY MAY BECOME DAMAGED AND UNSAIBLE.
